## Agreement

The payment of a deposit by the hirer constitutes an agreement to hire the use of the facilities from the campsite.

**Payment** – Full payment is required 5 days prior to arrival at the campsite. If necessary, any additional expenses incurred such as breakages will be invoiced to the hirer and payment is requested within 7days.

**Liability** - The Silverton Village Committee Inc., managers of the Silverton War Memorial Youth Camp and its agents & employees do not accept liability for loss of property, damages or personal injury arising from the use of the facilities. The hirer is responsible for ensuring that they have appropriate public liability insurance for their group.

**Cancellations** - Refunds of deposits will only be given for cancellations made 90 days in advance of the camp date. Groups cancelling with less than 30 days' notice to the campsite are liable for full payment of the first night. In the event of a cancellation by the campsite, the hirer shall be entitled to a full refund of monies paid.

**Privacy Act** – The campsite give assurance that any personal information including gathered by the campsite or provided by the group leader will remain confidential and only be used for the purpose of which it was collected.
